Loving Service Foundation (LSF), is a non-profit charitable foundation (501c3) (EIN# 20-2875352) established on April 4, 2005. LSF is situated on 22.5 acres of forested land at the 5400 foot elevation of Hualalai Mountain on Hawaii Island. It is a very peaceful and healing environment for the youth we serve. 80% of the patients served are from disadvantaged populations and we are serving a relatively poor rural area of Hawaii.

Our mission is to provide psychological treatments to children and adolescents using traditional and multi-disciplinary treatments. Treatment interventions are more effective when addressed by a variety of approaches.

In addition to direct service provided by Reuben Lelah, Psy.D., Hawaii Licensed Clinical Psychologist, the Foundation will award scholarships and other financial assistance and or information to allow individuals and their immediate family members to travel and obtain psychological evaluations and brain scans at leading research facilities and universities.

The Foundation will perpetuate the efforts of the Grantor toward providing dynamic and high quality psychological services to those who would otherwise not have financial ability to receive such services.

The Foundation will evaluate and fund children's clinical and collateral non-clinical programs and initiate the same on Hawaii Island according to available funding resources.

I work with children and adolescents who have a variety of very challenging concerns and specialize in working with children and teens who are dying or who have chronic illness. Currently, we are building a children's music therapy center and accompanying garden to be used to train youth to quiet themselves as part of their healing and coping (this is only one important part of their overall treatment regimen). The music therapy center will house state of the art equipment to be used in music and sound therapy and research. In addition, we are developing an environmental therapy center where youth who are challenged by a variety of chronic illnesses will receive experience with growing organic vegetables (we have built two beautiful glass greenhouses), Hawaiian medicinal plants and helped with recipes and diet improvement for better brain, immune and general body functioning.

With improved brain functioning, many behavioral challenges disappear obviating the need for costly, extended psychotherapy treatments and often, the plethora of medications used for challenges like attention concerns in our youth.

A current specific planned program is to incorporate the children's exercises (skills training in focus and concentration), addressing dietary concerns as well as the use of traditional individual and family interventions (therapy and skills training) for Attention Deficit Hyperactivity Disorder. This program is to help lessen the need for medication interventions or to keep medication intervention to a minimum.

About six years ago, a brand new children's clinic was built to serve our youth. As can be imagined, our projects have been very costly for this needy and well deserving population. Now that we have Federal and State Public Charity status, it allows us to write to you requesting monetary help or in-kind donations. We are currently trying to raise \$1,500,000 to complete construction of the music therapy center and very beautiful garden as well as complete construction of the environmental center.
